BOARD MEETING

THURSDAY, FEBRAURY 12, 2015 AT CARSON STATION

Meeting was called to order by President Candy Roper, 11:43am. All board members were present with an additional 2 of the committee Chairman's, Judy Johnson Chief Ring Steward and Tony Yarbrough Legislature liaison. Motion by Sieg Goepner to accept the last board meeting minutes that were printed in the Newsletter , 2nd by Bob Newman, motion passed.

Treasurer Bob Newman report: a January 2015 balance of \$26,200.78, after expenses of \$350.00 to AKC for our dog shows and \$19.95 to Breederoo for the club website. Balance also included the income from dues. Our current balance is \$26,035.55. A printed report was not printed due to computer problems.

Corresponding Secretary Gail Speiker has received confirmation from AKC approving our shows for September 26 and 27th, 2015.

Recording Secretary Judy Davis, announced that she will be adding new features to the newsletter in an effort to gain more members involvement by creating informative and interesting articles. Request to the membership for their input of what they would like to see in the Newsletter. Also if they themselves have a article that they would like to share with the membership. It would be greatly appreciated.

COMMITTEE REPORTS:

Legislative Liaison, Tony Yarbrough provided a list of bills this legislative session that pertain to animal ownership, care, police powers and other issues that could affect us as owners, exhibitors, or breeders. He provided a first copy of AB119 which would increase law enforcement capabilities along state lines, allowing them to cross into Nevada if they see fit to deal with animal enforcement issues. The bill has been introduced but no hearing is scheduled yet. Chris Vaught is watching things closely. She has teamed up with NAOA (Nevada Animal Owners Alliance) this year. Tony is spending three days per week, six hours per day, on average, at the legislature this session. Monday, February 16, the animal rights advocates will be at the legislature. The animal welfare groups-like us-will be there Thursday, February 19 from noon to 4:pm, to present a united, reasonable front to our legislators.

SHOW COMMITTEE REPORTS:

President Candy Roper reported that all judges with the exception of one obedience and rally judge have been hired and most contracts have been received. We have been approved by AKC. Rick Berger is currently working on their assignments. Rick helping out is greatly appreciated by President Candy. Candy also wants to be sure that the National Anthem is be played this year. Problems have occurred and would like to have that corrected.. Tony Yarbrough said he may be able to help with the announcing.

Trophy donations:

Please contact Carolyn Goepner with your information, draft of the premium list is mid May final after approval 10 days. Truckee Meadows Dog Training Club has offered to steward for the obedience and rally rings again this year. The big cottonwood tree in the middle of Fuji park has been cut down. Plans are also to cut down the big tree in the parking lot.

Chief Ring Steward Judy Johnson report that she contacted the Professional Ring Stewards Association of Northern California to get a quote for conformation ring stewards. There are two options:

- #1. \$100.00 per day per steward. A Chief Ring Steward is \$125.00, there is no fuel charge or lodging fee. This fee includes their breakfast and lunch at the show grounds.
- #2. \$75.00 per day per steward and providing double occupancy rooms at the host hotel. President Candy Roper asked if there is a minimum number of stewards required. It was not known at the time and Chief Ring Steward Judy Johnson will check into it. Currently seven ring stewards are needed. Judy suggested that we raise the entry fee of \$1.00 this would cover the cost of seven stewards per day. Judy also would like to solicit volunteers so that there would be two stewards per ring. The professional inside and the volunteer outside.

After discussion, Vice President Sieg Goepner made a motion, seconded by Secretary Judy Davis, that the board recommend to the membership we raise our entries from \$25.00 to \$27.00 for the first entry and the second entry be left at \$20.00. In addition raising the overnight parking from \$27.00 to \$30.00 per night; and the preferred parking (along the sidewalk) for box vans \$27.00 to \$35.00 per night. Motion passed.

Board Member Elaine Oxborrow reported the Northern Nevada Belgian Tervuren Club has been approved for their Friday specialty. They are talking about opening their Friday obedience to all breed and are working with the Belgian Sheepdogs on the possibly joining us next year.

Match Chairman/Board member Cindy Craig asked if she can proceed with ordering match ribbons for this year. President Candy Roper told her she spoke with Carolyn Goepner two days ago and she will be placing a ribbon order by the first of March.. Cindy was asked to go ahead and get the information to Carolyn. July 11th, was chosen as the date for the summer match. The match applications need to be submitted so the September 26th match can be listed in the premium. Cindy will submit the applications. She would also like to ask the membership for a volunteer to take over the match chairman position to get more members involved.

Brie with Jeweled Fruit Compote

Quick and easy-serve with crostini or crackers.

1/2 cup dried tart cherries

1/4 cup dried apricots, sliced

1/4 cup golden raisens

2 tbsp. brown sugar

3 tbsp. brandy

2 tbsp. water

1 tbsp. fresh lemon juice

1 tsp. whole-grain mustard

3/4 tsp. chopped fresh rosemary

1/8 tsp. freshly ground pepper

Dash of kosher salt

6 small dried figs, quartered

1 (8oz wheel Brie cheese

Combine all ingredients except cheese in a Medium microwave safe bowl. Microwave at High 2 minutes, stir mixture, micro at high 1 Minute or until bubbly. Serve warm over brie. (I heat in a small pan on the stove top)
