Minutes of the General Meeting  
October 4, 2011**

The October 4, 2011 general membership meeting of the Bonanza Kennel Club was called to order by President Candy Roper at 7:18 p.m. at the Carson City Community Center.

Bob Newman moved to accept the minutes of the September 6, 2011 meeting as printed in the October newsletter. Taren Kinney seconded the motion. The motion was approved unanimously. Secretary Lynn McLellan had nothing new to report. There was no mail.

Bob Newman presented the Treasurer's report. We paid \$200.00 in advance for the phone bill, as suggested by the audit performed earlier this year. The chefs have been paid \$700.00 for judges and workers meals. We sold 101 catalogs. The pooper scooper was \$300.00. We received \$3,341.00 from overnight parking and the match. Bruce Rettick was paid \$710.00 for doing our parking. The German Shorthair Pointer Club of Reno was paid \$85.00 for their portion of the sweepstakes entry on Saturday. (This was \$50.00 from last year and \$35.00 for this year.) Hotel rooms for judges were all paid by the club in advance. Judges fees and expenses are all paid. Judy Johnson was reimbursed \$14.39 for copying newsletters. Our ending balance is \$7,143.51. We have two checks from Onofrio totaling \$14,619.70 that will be deposited tomorrow.

Cathy Coval asked about the status of the audit of the club's books. She questioned whether a review should be done as follow up. Bob Newman reported that the judge's contracts are reviewed by the show chairman prior to paying their bill, and as far as he knew, all suggestions made by the committee had been addressed. Candy Roper had the list from the audit committee which was presented to the board, and she read it. She sent the judges contracts to the chairman of the audit committee, Lexine Thompson, as requested. Everything on the list has been done except adding fields to Quick Books for better descriptions of transactions. Lexine has not been available to do this for us yet.

**COMMITTEE REPORTS:**

**SHOW COMMITTEE** – Candy Roper gave the Show Committee report which began with a thanks to all who worked to make the show successful. She gave an extra thanks to Nancy Gammie for helping with Judge Iwamoto and his wife when Mr. Iwamoto became ill. Candy called Mr. Iwamoto yesterday. He had seen his doctor Monday morning and was doing well. He did not accept any judging fees even though he judged on Sunday. There was a motion by Elaine Oxborrow, second Sieg Goepner, that we send Mr. Iwamoto flowers. The motion carried unanimously. It was noted that Nancy Craig covered for Mr. Iwamoto Saturday and was available if she was needed on Sunday. Motion Ann Kinney, second Elaine Oxborrow, that we send Nancy Craig flowers as a thank you. The motion carried unanimously. A limit of \$50 was discussed. Candy will send flowers to both judges.

Candy continued her report. She noted everyone was reported to be happy with the show. The food for the judges was good, and Stewart Mundy told us he would do the meals again next year. The long break in judging the toy breeds was due to a mix-up in Onofrio's office – for which they apologized. The only effect of this was to change the Group order. This was a successful show financially as the entries were up by approximately 125 from last year.

Sieg Goepner, Grounds Committee, proclaimed this to be our most successful show from his perspective. He said everyone was really helpful and wished to thank Harry Gammie who manned the gate for club parking, the Adams' kids, Charlotte Hilt, and Garrett Bowden for all of their help with setup and clean-up, as well as all their help during the shows, and Judy Johnson for loaning us a golf cart. Sieg also thought the B match went very well, and expressed thanks to Taren Kinney who worked very hard. He heard good comments from attendees.

Tony Yarborough expressed that he felt this was our best show ever with members working together. Harry Gammie noted the people he spoke with at the gate enjoyed the show and asked him to extend their congratulations to the kids for doing the match. Elaine Oxborrow said it was a nice show and the grounds were good, and everyone seemed to have a good time at the match. Ann Kinney remarked that the Park Rangers were very attentive to our needs. She asked them to put cans over the water puddles to cut down on yellow jackets and they were very helpful. She suggested a thank you be sent.

Cathy Coval asked questions about exhibitor parking fees and costs. As previously mentioned, the person handling the parking was paid \$710, and the overnight fees generated about \$3000 in income.

Taren Kinney reported on the B match. She thanked everyone who helped. There were 76 entries. Best puppy was a Pembroke Welsh Corgi. Best Adult was a Wire Dachshund. Elaine reminded Taren she must file a match report with the AKC. If she does not already have the form, she can download it from the AKC website. It was suggested the B match be done again next year.

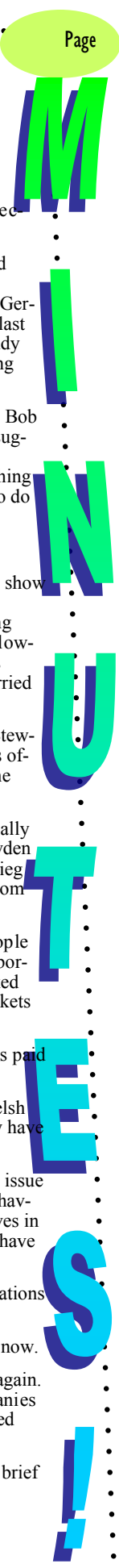
Carla Popeney commented about the inadequate quality of the National Anthem at the show on Saturday, and requested we fix the issue or replace the CD. Bob Newman said the player was too close to the amp which caused the "skipping" and feedback. We discussed having a live performance for the National Anthem. Suggestions followed. Elaine may be able to get Lacy J. Dalton to perform – she lives in the area. She was interested in doing it this year but had other commitments; she may be able to perform next year for us. We could have the local high school choir do it.

Tony Yarbrough is going to see if the Governor, Brian Sandoval, and/or a Carson City Senator might do our Best In Show presentations next year. The Mayor was unavailable this year, though he did try to make it.

Carolyn reminded everyone that if you wish to have a supported entry for any breed at upcoming shows, it needs to be considered now.

Elaine Oxborrow brought up distributing gift bags to overnight exhibitors like we did years ago. We need to consider doing them again. The Chamber of Commerce used to donate "Carson City" bags and brochures. Casinos donated pens and coupons. Pet supply companies donated products. The bags were very popular. Ann and Taren Kinney volunteered to help Elaine get items for the bags. We will need about 75 bags to distribute.

Cathy Coval needs volunteers to do a breed presentation at the November and January meetings. If you would be willing to give a brief presentation on your breed, please contact Cathy ASAP.

There was no new business. Elaine Oxborrow moved the meeting be adjourned. The meeting adjourned at 8:16 p.m.



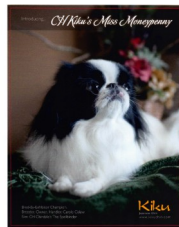

## PROPOSED GOVERNMENT RULE !ALERT! Importation of Puppies to the US—be worried—be VERY worried

The 2008 Farm Bill has added a new section to the Animal Welfare Act restructuring the importation of certain live dogs. APHIS has drafted proposed rules to implement this amendment and are ASKING FOR YOUR COMMENTS.

Forty percent of American households have a dog, the highest percentage in the world. As fewer American-bred dogs of the preferred sizes are produced, others sources have been developed. However... Diseases and parasites that have been eradicated in the US are now being reintroduced via dogs that are imported specifically for resale. Neither the countries from which they are sent nor the US have health regulations to prevent this. Documented diseases include Rabies (US had eradicated Canine Rabies), Canine Brucellosis, the screw worm that eats its host alive and can destroy our agricultural industry (from Trinidad and Tobago), along with common infections and parasites.

The dogs commonly arrive without health certificates from parts of the world that are rife with diseases that pose risks to both dogs and humans. Numbers show that over 18,000 dogs per year are coming through Chicago International and JFK airports. This count is from shipments of over 35 dogs. Resale shipments under that are not included!

In addition, the Center for Disease Control estimates that in 2006 over 199,000 dogs were smuggled over the Mexican border, of which more than 38,000 were not vaccinated. Some of the dogs were deliberately bred for this purpose. Others are street dogs. They are often sold in America by "roadside dealers." They often carry undisclosed diseases and health problems because of non-existent health requirements. Thousands of Puerto Rican street dogs are imported for non-traditional shelters, rescue groups, and pet supply super stores, all without vaccination or health requirements. Dogs have also been imported for resale from Afghanistan and Baghdad.

APHIS's proposed rules will require import permits for dogs entering the US over the age of six months for purposes of resale, research, or veterinary treatment. It would require persons importing dogs to identify themselves and their dogs, list ports of departure and arrival, and the date of arrival into the US. Dogs under age of six months could not be imported for resale at all. Individuals can still import dogs under six months for their personal use.

In addition, penalties for noncompliance are included. Health certificates and proofs of Rabies vaccinations must be written in English by a licensed veterinarian, and dogs refused entry can be removed from the US or seized by an APHIS official, with the person importing the dog held liable for the cost of caring for the animal/s.


