



Bonanza Kennel Club

The December 6, 2012, board meeting was called to order at 12:10 p.m. by President Candy Roper. Board members present were Candy Roper, Bob Kinney, Bob Newman, Elaine Oxborrow, Sieg Goepner, Gail Spieker, and Judy Johnson.

**Motion Bob Newman, second by Elaine Oxborrow, to approve the minutes of the November 2, 2012 board meeting as amended. Motion Carried.**

The Recording and Corresponding Secretaries had no report.

The Treasurer, Bob Newman, stated that the bank balance as of the meeting is \$24,461.40.

Candy announced that the next general meeting will not be held on the first Tuesday because it falls on a holiday (January 1, 2013). The first meeting of 2013 will be held on January 8, 2013.

**COMMITTEE REPORTS:**

**Web Site** - Candy stated that she has updated next year's calendar on the new web site.

**Show**

The contract for MBF to be the superintendent for next year's show will be signed today. A letter has been sent to Onofrio notifying them of the change.

There will be Shar Pei and Shiba Inu national specialties in Reno on the Saturday of our show. One of these clubs contacted Candy for permission to do so. Candy will talk to representatives of both clubs and offer them Fuji Park for free if they will hold their nationals there.

Candy contacted Heather Mundy to ask if she will continue to be chief ring steward and if she and Stewart will be able to do the food at next year's shows because of their involvement in the Shar Pei national. She has not received a reply as yet.

The task of selecting judges for 2013 is almost finished. We still need a couple of judges.

There was a discussion about dropping obedience and rally due to lack of interest. It was decided to hold them one more year and then re-evaluate. Candy will discuss the issue with Ladonna of Truckee Meadows Dog Training Club (TMDTC).

There was a discussion about the puppy and bred-by-exhibitor groups for 2013. It was decided to do one show with MB-F before we change anything (including dropping obedience and rally) so we can get a true representation of how the superintendent change affects our shows. There will definitely be a match on Saturday after the show.

The winter match was discussed and February 23, 2013 was selected. Carson Canine Adventures (CCA) has offered the building for \$400 but will forego the rental if the club agrees to split the profits with the CCA. Obedience and conformation will be offered if we can get help. Candy will contact TMDTC to see if they are interested in offering obedience and rally as RKC is unable to join us this time. BKC will offer a stewarding class prior to the match.

**OLD BUSINESS**

Candy Roper stated that she contacted the AKC about the club's bylaws which need their approval and has not heard back from them.

Candy, Bob Kinney, and Judy Johnson attended the meeting of the events committee of the Carson City Convention and Visitors Bureau (CCCVB). Candy made a presentation and requested \$5,000 in advertising dollars for next year's show. She received a call from the committee's chairman who stated that they will recommend approval of the request to the CCCVB.

**NEW BUSINESS**

The nominating committee was appointed. The chairman will be Carolyn Goepner. Bob Newman will represent the Board of Directors. Taren Kinney will be a member. Lexine Thompson and Mitze Reed are alternates. Judy will notify the committee members.
