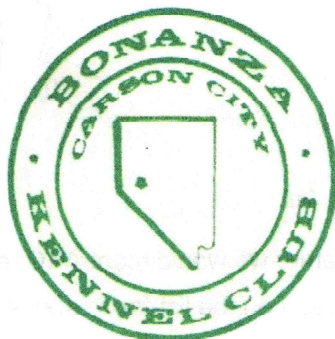

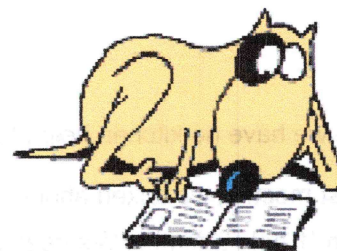

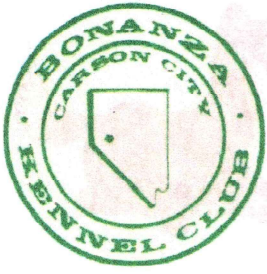

Candy's sister has a name of a potential caterer for the judges' food. Candy will give the information to Bob Kinney.

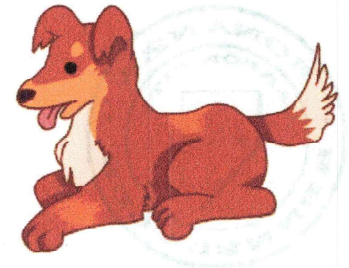
Carolyn will do breakfast ONLY if necessary. It would be coffee/muffins.

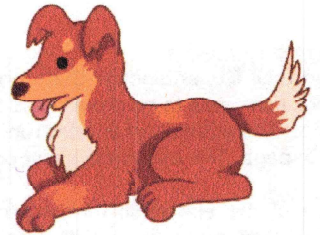
